

## TOURIST INDUSTRY.

This past week Edward Ecker, freshman Supervisor of East Hampton, proposed a Tourist Bureau to be included in the present reorganization of Suffolk's Industrial Commission. Mr. Ecker stated that Tourism, Eastern Long Island's most profitable present industry has been sadly unpormoted and underdeveloped. Moreover, in order to develop the Tourist Industry to its fullest potential a Tourist Bureau as part of the Industrial Commission is a must.

Central Suffolk Life agrees with Mr. Ecker. Tourism is a natural industry of E.L.I. It can grow and flourish bringing this area millions of dollars over the years without destroying the beauty of our ocean, sound, and bay beaches; the charm and quaintness of our villages; and our uncitified way of life. We have to do little to earn this money besides encouraging visitors to enjoy our abundant natural resources. We do not have to build new schools, heavy duty roads, or make tax consessions as often must be done to attract commercial industry.
