The Hovercraft has been developed by Republic Airdraft which is conducting its air cushion vehicle program under a special licensing agreement to use design features development by Vickers-Armstrongs Limited and Hovercraft Development Limited. This marvelous new craft rides on an air cushion above either water or land providing a nearly frictionless, evenly distributed load support which opens up land and water areas previously inaccessible to conventional vehicles. The Government is very interested in this new principle of travel and transportation. It also has tremendous advantages for commercial fields but development along these lines will come at a much later date due to cost.

Eastern Long Island should be proud that its area offers such an ideal setting for these experiments - accessibility to land and sea. Our official should encourage and promote industrial growth along these lines. We, as residents, should welcome any newcomers to the area and not turn our backs on progress. 


## WE LIKE RFK BUT!

The change of term proposal will be put to the voters in November. Unfortunately, the wordage of proposals is often so couch – ed in legal terms that it is difficult for the average layman to decipher just what he is voting for or against. It is our contention that if an elected town official is doing a good job he has nothing to fear from his constituents every two years. 


#### **ROTTEN WATER AND AIR IN AQUEBOGUE**

Meeting House Creek of the Huckebuck Park area has been polluted for years and steadily growing worse. Last summer the pollution killed thousands of fish whose corpses remained by shore for days making the air and water fouler than ever. Publicity of the incident caused Town, County, and State Officials to investigate the contamination.

It was suppose to have been cleared up. Unfortunately, it was not and this year the Health Conservation Dept. has declared the water and any of its products unfit for human use and consumption. It is allegedly being contaminated by waste emptied from the duck farms. The duck farmers say they do not let the waste into the water but residents from the area say they do. In this day of advanced scientific achievement we are certain our health officials can certainly ascertain the cause of contamination. If it is the duck farms that are causing it they must be stopped. One industry must not be allowed to ruin the real estate value of a community; create a health hazard; destroy fish and shell fish for consumption; and negate any recreational advantages that usually accrue to waterfront life.

This contamination and its correction is not only important to the residents of Huckebuck Park, but to every resident of Suffolk County. Indian Island, the land the County recently purchased for a County Park, is right on this foul smelling water. Hundreds of thousands of our tax money



went to purchase a public park in which we could go boating, swimming, picnicking, and follow other outdoor pursuits. Right now the land is practically worthless for these purposes due to the pollution.

The politicians may not care about the big waste of our hard earned dollars but each and every resident of Suffolk County should demand immediate action to clear up the contamination. This situation smells in more ways than one.

#### **NO FOUR YEAR TERMS IN RIVERHEAD**

The Riverhead Town Board has set September 1st. for a public hearing on turning the present two year term of Town Clerk, Superintendent of Highways, and Receiver of Taxes into four year terms. As we stated in last week's editorial we feel that longer terms on a local level will not give us better government and only increase the chance of poor, inefficient government.
