

### UNITY MAKES STRENGTH

English has always been the official American language. Immigrants from all over the world have come to this country to build a better way of life. Some spoke German, some Spanish, while others conversed only in Chinese. However, whatever their native tongue all had to learn the English language in order to vote. Now, the Senate has amended the voting rights bill so that American citizens illiterate in English will be able to vote if they can show proof of an 8th grade education in any state, the District of Columbia or Puerto Rico. This ammendment is supported by both New York State senators and Congressman Lindsay, recently announced candidate for New York City mayor. We contend that their motives are political rather than humanitarian. Necessity is the mother of learning. Most of us have spent many years of learning a foreign language only to have it go to waste because we never need to use it. Immigrants to all countries acquire the native tongue much faster when their survival ends upon it. Moreover, in order for any country to grow and prosper its citizens must be able to communicate with each other. How can our citizens vote intelligently when they cannot understand what the candidate is saying or read about the issues. Any linguistic expert would testify that the original meaning is often lost through translation. We urge you to protest to Senator Kennedy and Senator Javits and to ask Congressman Otis Pike to defeat this ammendment to the voting rights bill when it comes before the House. All United States citizens should be able to speak English if they are to exercise their franchise. And Why Not?

### RIGHT TO WORK

President Johnson urged Congress to repeal the "right to work" laws of the Taft Hartly Act. Organized labor threw their whole hearted support behind Johnson in the past election. The President obviously feels he must support their cause now.

The right to work laws are in section 14-b of the Taft Hartly Act. They allow a man who is non-union to work in a unionized company. Labor wants a closed union shop. It wants to deny the indivils' right to be non-union. This is wrong. No one should be forced to belong to or not belong to any organized labor, social, or business organization. This Country's greatness is founded on individual enterprise, freedom, and human dignity. Society

and organizations are to serve man not man the society or organizations. Johnson and Congress should not allow themselves to be pressured into giving away one more of our freedoms - the right to work.

#### SHEER VANDALISM

This past Sunday some young hoodlums tore apart the irrigation system of the County Center. Such sheer vandalism is a disgrace. Are some of our youngsters so bored with living and so valueless that they must wantonly destroy in order to get a few kicks out of life? What kind of parents bring up children who have no respect for property that is not theirs? We hope their parents and the Courts will cooperate and deal effectively with these problem children. Delinquents often grow into criminals if they are not straightened out.

### **BAD POLITICS**

Suffolk County Democratic leader Lawrence Delaney recently exerted his political pressure to kill two bills in Albany. These bills would have created very badly needed judgeships. Mr. Delaney appears to have done this in retaliation against Cromarty's refusal to nominate a judge with bipartisan support. Neither Cromarty nor Delaney care a great deal that Suffolk County has a terrific backlog of legal cases to be tried in the Courts. The present number of judges cannot take care of the huge number of cases that have accumulated. We desparately need more judges. How could Cromarty and Delaney use the creation of new judgeships merely as a political football. Our two party system is supposed to insure good government and a lawful civilization not to destroy public respect for elected and appointed officials because of such political travesties.

Judgeships must be more than political weapons in the hands of the machine. They must be filled by men of character and wisdom not just by men who deserve to be rewarded by the party. The people should elect their judges. They should have a choice of two able men put up by the Democratic and Republican parties.

We are all Americans first and Democrats and Republicans second. Delaney and Cromarty should both reverse their positions and cooperate to create sorely needed judgeships for Suffolk County, and then allow the people of this county to decide who they want to judge them. And Why Not?

### GREATER YOUTH OPPORTUNITY

This past week many businesses received a letter and brochure from the Secretary of Commerce outlining President Johnson's Youth Opportunity campaign. It is an appeal to employ more young people during their summer vacations. It stated that government agencies have been instructed to hire one young person for every 100 temporary persons employed.

We have no doubt that young men and women of college and high school age should be occupied during the summer months whether they be needed at home or on a job. However, we didn't realize that big and little business had been turning young people away. In fact a few short years ago we always found temporary summer employment and so did all our friends. The federal government seems to be just butting into another phase of private life. Ironically President Johnson urges that young unskilled boys and girls be hired while at the same time he wants the minimum wage to be raised to \$1.50. What small business (aside from the summer resort business) can afford temporary unskilled help at \$1.50 an hour? Are our taxes supporting a government grown so big and bureaucratic that its directives are contrary to present legislation before Congress? Does the American way of life need so many government suggestions and interference in order to flourish as a democracy?
