Indexing proposition for state

Assembly Republican Leader James L. Emery has introduced legislation for indexing State income taxes to inflation. In announcing the prig sed legislation, Emery said, "This measure will help protect New Yorkers from the vicious cycle of inflation triggered tax increases." Emery is dead right.

For the past four years Suffolk Life has been editorializing about the injustice created when inflation pushes people into higher tax brackets, and forces them to pay larger percentages of their incomes for taxes. You the taxpayer have been unwittingly taking it on the chin while the state and federal governments reaped the benefits.

You have probably wondered why you cannot keep up with inflation despite raises which seem large.

If in 1969 you made \$10,000, you paid income taxes at a rate of 14 per cent. Assume a 1969 dollar bought a dollar's worth of goods and an equivalent salary today is \$20,000. By the standards of 10 years ago, today's dollar is only worth 50 cents in actual buying power. If we were not operating under a progressive income tax system, you would be breaking even. But, because we operate under a progressive system of taxation that is supposed to equalize people's wealth, you now are considered rich, and instead of paying 14 per cent of your income for taxes you are paying close to 36 per cent to the government. Your tax obligation on \$10,000 in 1969 would have been \$1,400 leaving you with \$8,600. Today your tax liability based on the \$20,000 inflated income, is \$7,200. That leaves you with an inflated \$12,800, which is actually worth \$6,400, 1969 dollars. Because the progressive income tax has not been indexed to inflation in 10 years your buying power has been reduced by \$2,200.

This example is typical of what has happened to most of us. The effects of inflation on the progressive income tax system is the real problem. It increases state and federal government revenues and has eliminated the need for a legislative income tax increase. It is the reason why the government has been involved in wild and reckless spending and why none of us can manage to keep our heads above water these days.

The Emery bill will bring long overdue relief to the situation. Through a formula, it adjusts income taxes to reflect the impact of inflation. As our salaries increase to compensate for the effects of inflation, the tax base and the various tax brackets are

action on this bill is, do not be surprised if it goes no where. Politicians on both sides of the aisle are opposed to a law that mandates indexing. Inflation has been the saviour of many of these politicians. They point to the percentages and say they have not increased taxes. Technically they are right. But as a taxpayer, you know you are paying more in taxes

Why are we being panicked

For almost two decades, oil prices ne United States were stable, then, in the early 1970's, the major oil companies seized upon the disruptions in the Middle East as an excuse to boost prices.

ensuina shortages. manufactured or real, provided the justification for nearly doubling the prices of nearly all petroleum products.

In 1974, home heating oil costs jumped from 25 cents per gallon to around 45 cents, and gasoline rose from less than 40 cents per gallon to over 60 cents.

During the latter part of 1978 and the early months of 1979 prices have jumped as often as twice a month. Again the blame for these outlandish increases has been placed on the problems in the Middle East and in

We have been fed a steady line of

bull that the supply of oil is in a perilous situation. Yet, it is common knowledge that there are super tankers filled with oil at sea, throughout the world, ready to unload their cargo when the price is right. The scarcity of oil is no more real in 1979 than it was in 1974.

The cause of the increased prices is the same as it has been in the past; the greed of unregulated, uncontrolled American oil companies. The federal government plays into the hands of the oil companies by accepting, as gospel truth, information presented by the American Petroleum Institute, the oil companies' lobbying group. What is even worse is the panic created by the government with their talk of rationing. Not only is the idea frightening, but the government is coming up with fotally unrealistic rationing plans that will favor the

very rich and those who live in cities where mass transportation is a reality.

About half of America grew up during WWII, and we have at least a vague recollection of the hardships and corruption that accompanies rationing. But the other half of America doesn't have any idea of how rationing will affect them. Maybe this is good because younger people tend to be more vocal, and you would have near riots on the streets if they didn't believe the government and were badly inconvenienced by a rationing program.

It's bad enough we must pay the absurd increases to the oil companies because they are no longer competitive, but when we turn to the government for help, it refuses to allow even normal competitive forces

to operate. The oil companies today are stronger and more effective than they were during the early days of John D. Rockefeller. The government either by design or incompetency is doing nothing to change this situation.

As much as it hurts, most of us will adjust our lives so we can maintain an auto, heat our homes and use the electricity to run our machinery and illuminate the darkness. We have no choice, but on top of paying exhorbitant charges, we don't need artificial rationing that will create additional hardships.

What this country needs is another Teddy Roosevelt who would speak softly to the Seven Sisters, and, if they didn't listen, take his big stick and beat the hell out of them. And why

Rally around the bluefish

Bluefish are considered the least attractive game in the sport fishing world, because they are overly abundant, and because many people prefer dry, flaky fish and bluefish is oily. The bluefish, however, is the backbone of sport and recreation fishing, and it is destined to go the way of the tuna if purse seiners are allowed to harvest them.

The purse seiners traditionally followed the tuna from their spawning grounds in the Gulf of Mexico up the coast and had no need for bluefish. But the establishment of catch limits on tuna have forced them to revise their practices.

Under the current regulations, the limits are generally reached by the middle of June when the bluefish first hit our shores in great abundance.

During the last two years, a preserving process has been developed that allows bluefish to reach the Eastern European and Asiatic markets in a palatable state. These markets have created a tremendous demand and, as a result, the purse seiners want authorization. so when their tuna limits are reached, they can come into our waters for bluefish.

Bluefish are about the only fish left that sportfishermen can catch on a regular basis. They appear in our waters in early May, and remain through November, and range in size from snapper-blues, under one pound, to what, are commonly called alligators, over 15 pounds. Bluefish provide hours of recreation for literally thousands of anglers from Maine to Florida.

The waters off Long Island once were abundant with tuna and it was the most sought after fish, but commercial harvesting by purse seiners reduced the schools to minute numbers, killing what once was a productive fishery. The number of other sport fish, like swordfish, marlin and make have also been depleted, leaving only the bluefish to fill the void.

A reduction in bluefish will end recreational fishing and industry which literally pumps billions of dollars into the East Coast economy every year. Few bluefish go to waste. As meat and other fishes have become more expensive, bluefish have become a regular part of many people's diets. Properly prepared, it competes well with any other fish.

If you are concerned about the cost of food, and-or are an angler who has enjoyed the thrill of fighting a bluefish, we strongly urge you to contact the Marine Fishery offices and protest their extending to purse seiners the right to fish for bluefish. It will salvage the most important fishery we have left. The address is the Federal Building, Dover, De. And why not?

Answer, Please Mr. Klein

We are heartened, at long last, to see County Executive Klein answer the editorials in Suffolk Life. Many of our past editorials have asked the **Tounty** Executive questions our aders wanted answered. We hope Mr. Klein will continue to answer these questions, helping to make the citizens of Suffolk County better informed and more qualified to judge how well the County is being run.

One topic of continuing concern has been the fate of the Suffolk County Airbase. Mr. Klein, you have consistently maintained there should be no development or binding agreement made concerning the utilization of the airbase until a master plan is completed. Why have you suddenly changed your position? This question leads us back to many others that have thus far gone unanswered.

The Suffolk County Airbase was turned over to the county at the same time its sister base at Presque Isle, Maine was given to municipal managers. At Presque Isle, the leaders turned the base into a valuable asset. They used the base for a job training facility and rented the existing structures to new industry. They provided for further economic development of the base through bonding cooperation, and most important, eliminated the bureaucratic red tape which made leasing the facilities difficult. has all helped facilitate turning this operation into a valuable property instead of a liability.

What Presque Isle did was brought to your attention on a number of occasions. Why didn't you provide the leadership to have this happen in Suffolk? Why have you allowed (or have you created) the bureaucratic maze that forces a potential lessee to spend up to six months waiting to find out if the county will grant a lease?

Furthermore, Mr. Klein, why have you insisted that the Federal Aviation Administration not allow any nonaviation operations to rent buildings on the base? When the Citizens Advisory Committee was able to get the F.A.A. to acknowledge that they were

only interested in the facilities east of Rust Avenue, adjacent to the runways and service areas, why, Mr. Klein, did you not cooperate with the Citizens Advisory Committee?

Mr. Klein, after the contract for the master plan was signed and the project was in the developmental stage, why did you agree to the creation and offer funding for a free trade zone outside the perimeter of the airbase? There is more than adequate space within the perimeter which could be used. Our list of unanswered questions goes on. In addition to our confusion over your efforts to create the free trade zone, we can't help wondering about the choice of location.

Mr. Klein, didn't you read the Dixon-Spears master plan report which recommended the creation of a new north-west, south-east runway?

The proposal which is expected to show up in the completed master plan, places the strip right in the middle of your proposed free trade zone area. We are forced to wonder about your judgement, and why you decided to lend your name to the creation of a free trade zone at this time?

Mr. Klein, when the F.A.A. agrees to fund a master plan they require continual community input to insure the project is compatible with the surrounding area. Have you, as County Executive, made sure there has been regular communication between the master planners and the community so the funding for this report is not jeopardized?

Mr. Klein, why have you supported the Skylift proposal for utilizing the airbase as a debarking point for cattle to the Far-East prior to the release of the master plan? Mr. Klein, why did you rush into signing the Skylift lease when substantial questions concerning the operation have been raised by the State Department of Environmental Conservation. Mr. Klein, why have you tried to force the establishment of the Skylift operation against the will of the surrounding community, who rightly feel a cattle

moving operation would irreparably damage the local economy?

Mr. Klein, as chief executive and an interested party in the development of the airbase, you must be familiar with the deteriorating runways. cording to reports, the runways cannot withstand heavy use without serious, major complications. Mr. Klein, did you consider that by your signing a lease, the county might be saddled with the cost of rebuilding the runways?

Most, importantly, Mr. Klein, have you, as County Executive, Chief Planner and Executive Officer, ever asked yourself if we need an airbase of this size here in Eastern Suffolk?

There are many other questions, Mr. Klein, that we and the residents of Suffolk County have asked and you have ignored. In your new policy of answering truthfully, we hope you will address these subjects. We will be delighted to print your answers. And why not?

The Bass Anglers Sportsman Society, under invitation from the Alexandria Bay Chamber of Commerce, will hold their national tournament during the first week of the bass season. This rape of the spawning beds was done in 1978, despite all protest that fishing in such manner is both unsportsman like and that no expertise whatsoever is required in catching the aggressive male bass that are guarding the beds. demands that this tournament be held in later sporting season, such as was done in 1977, were laughed at. The season is open and they do what they please!

The Department of Environmental Conservation is involved, as they are using B.A.S.S. free labor in order to secure bass for All DEC involvement in river history has been minimal, so they condone the potential destruction of the fishery. It is claimed that 97.6 per cent of the fish are returned alive to the river. The real facts Alexandria Bay town dock, nowhere near the spawning beds. The "released" bass have been found dead and dying, downriver for three weeks after release! Sickly and starving bass have been caught with the metal jaw tags prohibiting proper feeding! We have spent the last season securing the evidence, the photos, the tags and the statements of witnesses!

Spawning bed fishing started last year from Memorial Day weekend until after the season opened. The 250 contestants could not, by rule, fish the river prior to the tournament, but B.A.S.S. membership in total is 300,000 and they have a tremendous following. As a member myself, our publications are viewed as rather "cultist". B.A.S.S. is owned and operated by tackle manufacturers and we are constantly subjected to the hoopla that it is our moral duty to catch every bass in every water in the nation and release them, if they are uninjured. What does one do with an injured bass during closed season? atrocity of our already existing massive poaching has to be enhanced!

It is claimed by the tournament promoters that we are being emotional on the issue, or, we want the fishery for ourselves. It is claimed that the season would not be opened during the third week of June, if it was to damage the fishery! Yes, we are emotional, as someone has to have regard for the fishery, as the economic interests will crush the ecology every time! Your recent editorial regarding the Telephone Company and its request for increased rates suggests to me that "ignorance is bliss"

I well remember my father complaining about the fact that our basic monthly bill for telephone service was \$7.50 -- in 1924. So take a look at your basic rate today and clap your hands in glee.

It is doubtful that I will experience it, but I visualize that when the "feds" accomplish the desegregation of the Bell System, General Telephone and others in like category that you ain't seen nuthin yet. The competition being set up on the lucrative routes which have been contributing to the cost of our service will one day result in or approach

extremes such as Mexico City and some Latin American countries where a telephone in-stallation costs \$550 - \$750 if you can get it.

When I moved into this house off a Town Road, I had telephone serve in three days at a nominal installation cost. Cable TV a good idea until I received a quotation of \$350 for a 300 ft. cable which costs ten cents a foot and an amplifier which costs less than \$75. On top of this, there is a charge of about \$8 a month for material they take off the air and maintain some microwave equipment, cable and amplifiers all in a confined area.

Why should we continue paying?

Last year, to the displeasure and sorrow of many Americans, the ted States of America took a giant backwards and gave up ownership and control of the Panama Canal Zone. In signing the treaties, which required the consent of the Senate but not the House, President Carter committed the taxpayers of the United States to funding canal operations through a transition period and into the future. But the aid requires Congressional approval and when the Canal Treaties were signed,

Congress was against granting it.

Last year we visited the Canal Zone to find out first-hand what the situation really was. Our investigations led us to the inescapable conclusion that the Canal Zone giveaway was motivated more by the United States banking interests which had billions of dollars in loans tied up in the Panamanian government, than by a Panamanian cry of nationalism.

We found that Panama was still ruled by a handful of extremely wealthy families as it has been for over two centuries, and it was our feeling that the small groups and individuals who attempted to rally around the Canal Zone on a platform of nationalism were more Communist inspired than interested in Panama as a country.

Panama will begin the canal takeover of the zone this coming year. Congress is still debating whether they intend to fulfill Carter's promise and fund through our taxes, the transition period.

Should Congress use our money for this purpose, or should it these expenditures which could cause an upheaval in Panama? We have to find out what the attitude of the Panamanian people is and what they have been told by their leaders. they do not receive funding, will they be able to maintain the operation? Will it cause an overthrow of the current government?

To find the answers to these and other questions, we are again visiting the Canal Zone and will report back to you first-hand. And why not?

Will deregulation work?

Most of us seek aid from our government to protect us against buses of big business and big abor. Aid is supposed to come in the form of regulations. But that does not appear to bring relief. A classic example is the airlines. The government attempted to regulate the airline industry. This was designed to create the maximum amount of routes, and supposedly impose economies which would result in lower fares. The airlines, themselves, opposed this in the early days, but fought tooth and nail against deregulation.

De-regulation of the airlines has already led to a reduction in airfares, particularly in overseas flights. As ridiculous as it may seem, the cost of flying from Kennedy to Miami round trip is about \$250.00. The cost of flying from Kennedy to Panama round trip As the airline industry is \$266. becomes de-regulated, we can expect other such economies.

As the energy situation worsens, two schools of thought are involved. One supports further governmental regulation of energy, including rationing, mandated closings, and arbitrary cut-backs. This will cause additional hardships, particularly on those with mean incomes. people will not be able to buy their way out of black markets that will Others favor total deregulation of the oil industry. They maintain that prices alone will create the desired effect of cutting back on our purchase of energy fuel. Also, they espouse the theory that if the government keeps its hands off fuel and energy, competitive factors will, in the long run, cause a reduction in fuel costs. Their argument is supported by the price reduction in the airline industry, which was the result of government de-regulation.

We all complain about the high cost of fuel. Realistically, the price of gasoline in 1950 was just under 30 cents a gallon. Today it is 75 cents. The minimum wage in 1950 was 60 cents an hour. It is almost \$3.00 today. The price of fuel oil in 1960 was 20 cents a gallon. Today it is about 60 cents. In 1960, the cost of a standard Chevrolet was \$1,900. Today, a comparable car is over \$5,000. Most products and services have doubled and tripled in price. Why shouldn't fuel?

Oil companies maintain there is plenty of fuel to be had here in the United States; that government regulation just doesn't make it profitable enough to take it out of the ground. Maybe it is time we stopped looking at the oil industry in such an unfavorable light. Unquestionably, they have done a lot to make us

suspicious, but have our government leaders inspired confidence by their actions? They tell us they would never lie to us, and then in the next breath maintain they never said that.

The one area in which the federal government could have been viable is breaking up the monopoly in the oil industry. The federal government should have acted firmly years ago, to insure that the major oil companies not be allowed to conduct a well head to service station operation. If there was competition along the marketing routes of oil companies, prices might have a chance of being kept in check through normal competitive factors. As it is now, the oil companies have become too big to be effectively regulated by government. All the regulations do is add to the cost of doing business, and it is the consumer who pays.

It would seem logic is in favor of deregulating the oil companies. effort being put forth in regulation should be re-directed to breaking the monopolistic hold the Seven Sisters have on the entire petroleum energy business. A re-thinking along these lines might reveal the answers to our manipulated, regulated, energy problem. And why not?

recall that way back in the late 1940's, I had a youngster, 17 years of age, come before me for sentence and the Probation Officer asked me to go easy with him as he was being graduated from High School that June.

I asked the boy what time it was and he stated "I don't have a watch." I then referred him to the Court clock and he stated "I can't tell time." I asked him if he could read or write and he replied in the "negative."

This was a situation that I considered intolerable, to foist a young person out with

There were three types of diplomas - Attendance, Effort and Academic. I told the Probation Officer that it was not fair to the youngster to be sent out looking for a job with an Attendance diploma from High School.

In answer to the question which usually appears on a job application, the person is asked about his education. He can truthfully say that he is a High School graduate and could not be accused of lying. Was this fair to the youngster? Upon being requested by his employer to do something that required simple educational knowledge, he would be unable to answer and would of necessity be

It was, at that time, that "tiered" diplomas became a part of the education system and it cannot be estimated what harm this system did to these youngsters over the years.

It was not fair to the public, nor to the youngsters, to give them a "tiered" diploma and have them go out in the world un-prepared and under false pretenses.

Undoubtedly, as a result of the education given to this youngster and many others over the years, they were subjected to the same of "lack of instruction" from some members of the Board of Education.

A good many of the teachers today do not take the time to help the youngsters as was done by the teachers way back in the early part of the century. Thank God, there are some dedicated teachers still in the system, but it would not hurt any of them to do as was done in the days when they saw that a youngster was slow in absorbing the class work, to keep them after class for additional instructions. There are so many of these

youngsters who, because of the thoughtfulness of the teacher, became quite successful in the business world.

When I went to school, I was not in a position to get help from my parents because they were comparatively recent entries into the United States and were unfamiliar with the language and the educational systems. They were from Italy and had not been here in America long enough to absorb the customs. They did, however, manage to support us and what they lacked in knowled of the United States customs, they made up in teaching us manners, respect and application of our studies.

I repeat, I like your article and hope that it gets through to those who will not give extra minute of their time for which they are not compensated.

Education is the most important part in our foundation in life and without it we cannot get too far in the competitive world, although w all know of persons who have succeeded to spite the lack of an academic education, but these are the exception to the rule.

Keep up the good work and let us get dollar for dollar from those who should take the interest of the youngsters that they are teaching to heart.

It is the position of the League of Women Voters that a reputable property owner will accept the responsibility to abide by regulations established to protect all of us from inappropriate or unsafe use of land.

We strongly object to the too-frequent case of a land use being legitimized after the fact without town involvement in its planning or execution. We believe that the only way to maintain control of development, including control of drainage plans, parking and access rovisions, and appropriateness of use to the natural environment and the surrounding community is for the Town Board to deny every after-the-fact application, regardless of its appropriateness to the site, and require that the illegal structure or use be removed. We urge other residents to become involved in hearings for such rezoning applications and to let the Town Board know that you want the town's zoning ordinance enforced.

Further, we appeal to the residents of the town to be alert to new commercial uses in their neighborhoods and to assist with the enforcement by inquiring of the Planning Department and the Building Department whether these uses have the proper zoning and the required certificates of occupancy.
