

TAX PAYERS ARISE

The New York State Regents Advisory Committee has come up with a five point program designed to rob the taxpayer of his only defense against rocketing school taxes — to deny him the right to vote on his school budget. The Advisory Committee wants all budget decisions to be made exclusively by the school board. Another point of their program wants to lengthen the term of a school board member to three years. If these proposals become a reality we poor taxpayers will have absolutely no recourse against spiraling school taxes and irresponsible school board members. A lot can happen in three years when a school board is given free rein in its community.

School taxes, today, average over 45% of the local tax assessment. We all want our children to have the best education but realistically this education must be in harmony with the financial structure of the community. We need good teachers, and educational buildings that administrators, will fulfill the potential of our students. We don't need extravagantly designed schools with expensive woodwork, marble inlay, and acres of unused property that must be maintained. Some of the best colleges and universities throughout the world are in the midst of crowded cities and housed in modest structures. Yet our most gifted young men and women graduate from them enriched and ready to enhance our civilization.

The Advisory Committee urges larger school districts which we are against. Many communities that are geographically adjacent have very different socio-economic milieu. Bigger districts do not reduce school taxes but they do reduce local interests in education. Furthermore, sometimes the large central school is overcrowded. It must accept any and all pupils. Yet, it cannot enlarge its facilities when outlying factions are against new buildings. Bigness and uniformity are quite often liabilities rather than assets.

A school is a reflection of the community it derives its pupils from. It's unthinkable that the community should have no voice as to what kind of schools it can afford and want. The United States has grown and prospered because people from different communities all over the world contributed their particular talents and ingenuity to king our Country great. Why is it so popular today to abdicate our individuality, rights, and responsibilities? Taxpayers arise, don't give away your right to directly control the budget of your school. And Why Not?



BLACKMAIL?

The recent struggle between the Government and the titans of the aluminum industry seems a far cry from the free enterprise system which has always been the basis for our successful economy. Three of the biggest aluminum companies simultaneously announced a rise in prices to which Alcoa Aluminum concurred. We thought Anti-trust laws were supposed to protect the public from large corporations entering into collusion. An investigation should be made to find out if the aluminum companies were violating these laws when they all went along with raising prices.

President Johnson far overstepped the boundaries of executive power when he threatened to flood the market with 200,000 tons of aluminum. Such retaliation forced the aluminum companies to rescind their price rise and dealt another death blow to our free enterprise system. The Government financed with our tax money has become our competitor; a competitor who always has the upper hand and who almost places itself above the laws hich business must adhere to. If the Government had released 200,000 tons of aluminum on the market, the aluminum companies would have had to stop producing or reduce their prices lower than the Government's. What right has the Government to interfere with private business? Ironically, our Government leans more and more towards socialism at a time when the Communist countries of Europe are admitting that socialism negates creativity, growth, ambition, etc., and are turning more towards a capitalistic economy.

We hope Congress will be much more than President Johnson's rubber stamp in the upcoming legislative session and take action to protect our free enterprise system against monopolies and the mushrooming Executive Branch. And Why Not?

ALWAYS LOOK A GIFT HORSE IN THE MOUTH

Under the Federal Aid Program for poverty stricken children, there will be more than \$6,000,000 available to Long Island schools. These monies can go to all districts for special education projects regardless of whether they nain poor children or not. Unfortunately, this \$6,000,000 will not be given without restrictions. In order to qualify for this aid a school district must submit a special education project for clearance to the State Education Department.

SUFFOLK LIFE is not so naive as to believe that each school system can be self sufficient. However, all of us should realize that any federal money comes directly from us; that it is our money to begin with, and that a large part of each collected dollar financially sustains the internal revenue department and any services involved in the allocation of our tax money. It is only through Congress that we, the people, have taxation with representation but more and more of the government's functions are being taken over by the growing executive branch. As our taxes grow, so does the federal government, and so does its permeation of our private lives.

Most objections to federal aid to education have been based on fear of federal control in the classroom. The recent announcement that this \$6,000,000 will not be automatic but completely contingent upon approval of the state education department shows such fears were justified.

We are confident our local school boards and administrators can determine how this federal aid can be best spent without state interference. We urge all school boards to vigorously object to the restrictions the Federal government is putting on this school aid. And Why Not?
