

#### Tragedy or Opportunity

Initial reaction to the news of the forthcoming shutdown of Suffolk County Air Force Base was largely a feeling of impending tragedy. While some felt the expected adverse results have been exaggerated, the majority were predicting all kinds of gloomy prospects - mainly economic. The loss of a million dollars a month in buying power will be felt, no doubt about it. The loss of three - hundred jobs in the dead of winter will be mighty rough on those affected. It will be difficult to replace the air force families who involved themselves in our businesses, schools and hospitals. Lastly, we will deeply miss these families who have given so much to their communities.

On second thought, however, the losing of this base could be a gigantic boon to this area if handled properly. A few years ago a community in northern Maine, also in the heart of potato country, was faced with the same plight. Apart from agriculture, the military base was the area's largest industry. There were very few decent paying jobs so that the children, upon graduation, had to go elsewhere to find work. Sound like eastern Long Island? Well, the base closed; and stores and businesses suffered from the loss of the base payroll.

After the initial shock the leaders of the community lost no time in getting busy to salvage the situation. They secured the land and buildings from the government, they set up training areas for the personnel who could find no other jobs after the base closed. They attracted industry to the base by offering favorable financing and tax terms, a ready labor pool and good transportation. They turned a bad situation into an If those New asset in a short period of time. England vankees could do it, so can we.

Eastern Long Island has much to offer certain types of businesses. Close by are excellent recreational There is a fair sized labor pool, some facilities. skilled and the rest undoubtedly eager to learn new skills and trades. The Suffolk County Air Base facility would make a fine industrial - commercial complex. There are many businesses that wish to remove their research and development functions out of major metropolitan areas. Corporate headquarters are looking for new facilities outside of New York City that would allow them room for expansion and ready accessability. Industry that is non - hard, that does not remove huge amounts of water from the ground or pour pollutants into our soil would be ideal for the area. Assembly plants, everything from automotive to electronics and optics would be beneficial. We feel, in short, that the potential is unlimited if our leaders will only direct their planning and best efforts to such a development.

We, as residents, might just as well face the fact that the air base is going to be used as an airport. It was designed for that purpose and that is what it is going to be. Signing all the petitions in the world, writing to our elected officials and applying pressure tactics is not going to change that fact. What we must determine is the kind of airport facility we want it to be, Will we permit it to become a facility for air cargo and later on possibly a major jetport or would we rather have it as a field to serve the business surrounding it? Used as a light general airport, serving the commercial needs of the clients using the industrial-commercial complex to our way of thinking is the best solution.

We have a gold mine right here in our midst, Properdeveloped it could provide jobs, a tremendous economic boost to our area and tax monies so badly needed for a broadened tax base. Let's hope our elected officials get towork now to make this facility one of the biggest assets Suffolk has. And why not?

William Ronan, omnipotent head of the MTA, has put in his bid for the Suffolk County Air Force Base. He wants to bring the future to this facility under his jurisdiction. Mr. Dennison has given his blessing to this proposal.

Suffolk Life feels that this would be a great mistake. It would be very unfortunate if we gave up control of the development of this vital facility to some outside agency. If this base is going to serve our needs and be an asset to our economic development, it must be done in accordance with local planning. As we stated in last week's editorial, how this base develops can be a triumph or tragedy for our area.

Ronan has done nothing to justify the awarding of responsibility for the development of this base to the MTA. Mr. Ronan's schemes for the development of mass transportation has gone over like a lead balloon. He has succeeded in ruining the Long Island Rail Road, he's done little or nothing to improve the highways and all of his incompetency has been demonstrated while he sits on the biggest budget ever awarded to a state agency.

We were pleased to see that the Riverhead Chamber of Commerce let it be known that they favor the base be used as a general aviation facility. We hope that all Chambers of Commerce in the county do the same and communicate with state and federal agencies to that effect. Our leaders must show an active interest in the development of this complex. They must show that they wish to control its development and not turn that responsibility over to some massive outside agency that doesn't give a damn about the interests of the east end.

There is a lot riding on the future of this base. Much of our future economic development depends on how it is used. We would like to see all political parties, business associations, service clubs, town boards and county board go on record as favoring local control in the development of this facility. We urge all readers of this publication to contact their local officials and make such a request. Request that your clubs and organizations go on record as supporting the same.

This is not something that can be put off. Action must be taken now, and it must be made crystal clear that we mean business — that every resident of the area is FOR local control. The issue is not

political. It is a question of economics and it is going to play a big part in the future of our businesses and incomes. Let us act positively and wisely, and let us act NOW And why not?

#### Support the President

#### Tremendous Loss

We have been asked why we are opposed to the MTA taking over the Suffolk County Air Force Base. The person who questioned us pointed out that the MTA has unlimited funds to work with, the manpower to develop the field properly, the connections to bring industry into the area and the know - how to coordinate this facility with all mass transportation facilities within the state. On the surface these are all good arguments, but we feel the situation requires deeper consideration.

The residents of Suffolk County own approximately 2000 acres, or about two thirds of the Air Base land outright. This prime area includes the main buildings area, the flight control area, the runways and the major industrial development area. The federal government owns the remaining third which is an area comprised mainly of approaches to the run-The federal government acquired this land to prevent any development that might have hindered the jets' approaches to and from the runways and main base areas. These approaches are not worth much as development property because their location precludes their being used as anything but approaches.

What about the MTA? It is an authority with the power of eminent domain and is answerable to no one. Its officers are appointed by the governor, and it is virtually impossible for anyone to exercise control over them. Because it is an authority, it pays no taxes and makes no direct contribution to the community it surrounds. Its only contribution is its success or failure in performing its function as an authority. Consider the record of the MTA to date, with all of its money, high priced help, power and prestige, and you get some idea of how poorly we would fare in terms of value. Consider the plight of the Long Island Railroad under the MTA. It is also responsible for the completion of the L. I. Expressway, yet so far it has only opened a stretch between Brookhaven Lab and Calverton. The stretch between the Lab and Holbrook has been finished but, for some reason, it has not been opened. It has been said, sarcastically, that the MTA is waiting for the 1970 gubernatorial election so that Rockefeller can gain political mileage out of it. The MTA is responsible for completing the Sunrise Highway. Have you noticed the speedy operation? We haven't. Throughout the state you will find other

projects that were talked about when Rocky campaigned for the passage of the bond issue. They are in about the same shape as the Long Island projects. In addition to the MTA's miserable record of performance, it could bring any type of industry to the base facility that it deemed worthy. Hard industry with belching smoke stacks, heavy industrial use of water and/or pollution could all result at the whim of the MTA. The point is that the planning developed by the surrounding towns could be thrown out and there wouldn't be a darn thing we could do about it.

We feel that the Air Base facility must be used as an airport of some type - preferably a general aviation facility serving selected industry. county executive says fine but let's hook it into the jurisdiction of the MTA. We know the county executive has been a long-time advocate of a jetport out here. He knows, and we know, that once the base is under the control of the MTA with its power of eminent domain, it could convert this facility from general aviation to a major jetport. the county executive would have his jetport and he could blame it all on the MTA.

Suffolk Life feels that we have the people and the resources within the county to run this facility as a county proposition. It should be developed within the framework of our plans for the east end and for the primary benefit of Suffolk County. We must not abdicate our control over this development to an authority that has proven itself, beyond all doubt, a failure. We urge our readers to let their views be known on these matters to all of the elected officials of Suffolk County. Suffolk County must retain control of the development of the Air Base. And why not?
