Ford Addresses The Wrong Audience

Recently President Ford spoke at the United Nations about the ramifications of the Arabian countries black-jacking the world. He spoke of the ills which will result -- world-wide depression, hunger and inevitable holocaust. It was a grand speech. It produced an expected reaction from the Arab, world. They threatened to cut off supply if we threaten war. This is the way they interpreted Ford's remarks.

Ford's speech was good, but it was delivered to the wrong audience. It should have been delivered to the American oil interests, to the handful of families who control American oil companies and most of the other big businesses stateside. It is they who control the destiny of the world, not the handful of Arabs who are their scapegoats. Let's put things in their proper perspective.

First, it is American oil interests that created the marketing apparatus for the distribution of Arabian oil. These same American companies still own large shares of these oil companies and are directly benefitting from the Arabian price hikes. They are still providing the technical know-how and, to a large extent, the financing needed to make this whole deal swing.

Second, let's look at what has happened here in America during the past year. We are importing 20 per cent of our oil needs from foreign countries. This is not just Arabian oil, but oil from Venezuela and Canada.

The cost of this foreign oil is three times what it was a little over a year ago. At the same time, the retail price of oil we use in our homes and to generate electricity has more than doubled.

This is not right. A three-time rise in 20 per cent of the oil should only lead to a 40 per cent increase in the cost of the product when it is mixed with our domestic oil, if the price of domestic oil had remained stable. It didn't. Our domestic oil companies raised our oil prices, too. The result is, we are paying twice the price we paid last year, and the oil companies are profitting 60 per cent more than they should be.

President Ford must realize this, but he preferred to perpetuate the concept that the Arabs are behind all our ills. President Ford has the power to do something about it. He can demand that the anti-trust laws be imposed to break up big oil companies and once again make them competitive. We doubt he will do this. This is unfortunate, for not only the American public, but for the rest of the world.

His prediction of unrest, hunger and



eventual world war will come true because of a handful of families' greed. He could have done something about it, but for whatever reason he has, he didn't. It's a shame. And why not?

It's Tuesday. School has been out for almost an hour.

The telephone rings in the firehouse. "There's a house on fire ... 23 Hill Street. Please hurry, I think my brother is in there!" The dispatcher pulls the alarm and simultaneously broadcasts to the volunteer firemen over closed band radio the location and type of fire, and whether anyone might be trapped in the blaze.

Then all hell breaks loose.

Cars with flashing blue lights come racing from all directions. The area around the firehouse is organized chaos. Cars pulling in, trucks with sirens screaming and red lights flashing are racing out. It doesn't matter whether you are young or old, you feel the excitement, the tension.

Hill Street is four miles away. Firemen know seconds count. They push their trucks and cars. They hope other drivers will see their lights, hear the sirens and give way.

The four miles feels like 400. Somebody is trapped in that building, and a minute or even seconds means the difference between getting them out alive or carrying out a corpse.

There it is, number 23. There's no sign of smoke. Get the hoses hooked up. Must get inside, survey the fire, find the victim. The doors are locked! Have to break in. No smoke inside. No fire.

Ha! Ha! False alarm.

Why isn't anyone laughing? Didn't our little game give everyone a break in their dreary day? Wasn't it exciting? Didn't the trucks race fast? Yes, they did. The volunteers raced there just as fast as they could, just as fast as if there really had been a fire.

In fact, during the past few weeks here in Suffolk County, there have been several incidents of volunteer firemen = being seriously injured while responding 2 to a false alarm. Maybe drivers did not give way as they are supposed to. Maybe firemen took chances they normally wouldn't. Maybe people became confused. Whatever the reason, there are volunteer firemen lying in hospital beds who should not be there.


Turning in a false alarm is a crime, > one that should be prosecuted to the fullest extent of the law. It is serious enough in the city, where you have a paid fire department, but here in Suffolk, where the departments are made up of an all-volunteer force, it is unthinkable.

Our departments are made up of men from every walk of life who give unselfishly of themselves to protect their neighbors. Being a fireman may be exciting, but it is not fun and games. Hundreds of hours of training are needed to be a good fireman.

The chances they take at times are suicidal. Somebody has to do it and they have volunteered their services. Every time the siren blows, they lay their lives on the line. Fires happen and they accept the risk willingly.

We do not need false alarms. We should not tolerate them.

Parents, impress upon your children the seriousness of this situation. Your children should realize the consequences of turning in a false alarm ... not only what will happen to them in the eyes of the law, but the jeopardy they place the firemen in. Talk to them, explain it to them and let's hope there will be no more false alarms. And why not?
